July 11, 2017

The Board of Education for Pleasanton Public Schools, District 10-0105 met in regular session at 7:00 p.m. at the school. Members present were Zwiener, Pawloski, Hand, Nichols, Loeffelholz and Kingston. Linda Kohlscheen was a staff representative.

Meeting called to order by President Zwiener and opened with statement that the board follows the open meetings law and a copy of the law is located on the back wall.

Motion by Pawloski, seconded by Loeffelholz to adopt the agenda. Motion carried 6 – 0.

Motion by Nichols, seconded by Kingston to approve the minutes of the last regular meeting. Motion carried 6 – 0.

Motion by Pawloski, seconded by Kingston to approve the treasurer's report. Motion carried 6 – 0.

Motion by Hand seconded by Pawloski to approve the last month's bills. Hand. Motion carried 5-0. Nichols (abstained)

Motion by Nichols seconded by Pawloski to approve policy 505.7 School Meal Program. Motion carried 6 – 0.

Motion by Pawloski, seconded by Loeffelholz to approve policy 505.6 School Wellness. Motion carried 6 – 0.

Motion by Kingston seconded by Hand to approve policy 603.8A Title I Parental Involvement. Motion carried 6 – 0.

Motion by Kingston seconded by Nichols to approve policies 501.1 and 501.1A Attendance Requirements and Excessive Absenteeism, 505.5 Student Fees, 603.8 Parental Involvement and 1108 Bullying (not 502.6 as stated in the agenda). Motion carried 6-0.

Motion by Pawloski, seconded by Loeffelholz to approve a 2017-18 pay increase of 4% for Administrative Assistants. Motion carried 6 – 0.

Motion by Nichols, seconded by Hand to approve a 2017-18 pay increase of 0.25 per hour for Para educators. Motion carried 6 – 0.

Motion by Hand, seconded by Kingston to approve a 2017-18 pay of \$21/hour for Bus Route Drivers and \$13/hour for Bus Activity Drivers, drive or sit time. Motion carried 6-0.

Motion by Pawloski, seconded by Kingston to approve a 2017-18 pay of \$112/day for Substitute Teachers. Motion carried 6 – 0.

Motion by Nichols, seconded by Loeffelholz to correct the elementary lunch price to \$2.70 not \$2.60 per the May meeting. Motion carried 6 – 0.

Motion by Hand, seconded by Nichols to approve the 2017-18 Student Handbook. Motion carried 6 – 0.
